Complaint and protest: Complaint in written form within 30 min. after display of unofficial results.  
Protest in written form within 30 min. after display of official results.  
Protest fee to the ONF: € 72

Prize Money: € 2.000.- (1000€ if there are less than 3 flown tasks)

Competition will be held according to the CIVL Sporting Code and the Austrian Competition rules.  
Wrong information at the registration and violation against the flight rules will result in disqualification.
